# MORE PARASITES, MORE PROBLEMS


 **TICKS** can spread many diseases to dogs, like babesiosis, Rocky Mountain spotted fever and Lyme disease.<sup>1</sup>


 **FLEAS** can become a big problem quickly, both on your dog and in your home. Female fleas can begin laying eggs within 20-24 hours of their first blood meal and can produce up to 50 eggs per day.<sup>2</sup>

 **HEARTWORM DISEASE** can be fatal and has been diagnosed in all 50 states. Even when treated, heartworms can cause lasting damage to a dog's heart and lungs.<sup>3</sup>

 **TAPEWORMS** can grow over 2 feet inside your dog. One type of tapeworm, spread through fleas, can infect your dog through flea ingestion.<sup>4</sup>

 **WHIPWORMS** spread by eggs in dogs' feces and can survive in the environment for years.<sup>5</sup> Many preventives, however, don't cover it.

 **HOOKWORMS** can cause diarrhea and anemia, and are particularly dangerous for puppies.<sup>6</sup>

 **ROUNDWORMS** are a very common parasite that can be transmitted when dogs come into contact with contaminated soil. Puppies are especially vulnerable since larvae can be passed through their mother's milk.<sup>7</sup>

## INDICATIONS FOR CREDELIO

Credelio® (lotilaner) kills adult fleas and is indicated for the treatment and prevention of flea infestations and treatment and control of tick infestations (lone star tick, American dog tick, black-legged tick, and brown dog tick) for one month in dogs and puppies 8 weeks and older and 4.4 pounds or greater.

## IMPORTANT SAFETY INFORMATION FOR CREDELIO

Lotilaner is a member of the isoxazoline class of drugs. This class has been associated with neurologic adverse reactions including tremors, incoordination, and seizures. Seizures have been reported in dogs receiving this class of drugs, even in dogs without a history of seizures. Use with caution in dogs with a history of seizures or neurologic disorders. The safe use of Credelio in breeding, pregnant, or lactating dogs has not been evaluated. ## INDICATIONS FOR INTERCEPTOR PLUS

Interceptor® Plus (milbemycin oxime/praziquantel) prevents heartworm disease and treats and controls adult roundworm, hookworm, whipworm, and tapeworm infections in dogs and puppies 6 weeks or older and 2 pounds or greater.

## CONSUMER BRIEF SUMMARY FOR INTERCEPTOR PLUS

**Information for Dog Owners** – You should read this information before starting your dog on INTERCEPTOR PLUS. The risk information provided here is not comprehensive. Talk with your veterinarian if there is something you do not understand or if you want to learn more about INTERCEPTOR PLUS. **Always follow your veterinarian's instructions for giving your dog INTERCEPTOR PLUS.** Ask your veterinarian, call 1-888-545-5973 or visit [www.interceptorplus.com](http://www.interceptorplus.com) to obtain the full FDA-approved drug labeling.

### What is INTERCEPTOR PLUS?

- INTERCEPTOR PLUS is a monthly chewable tablet, available by prescription only, used to:
  - Prevent heartworm disease caused by *Dirofilaria immitis*.
  - Treat and control adult roundworm (*Toxocara canis*, *Toxascaris leonina*), adult hookworm (*Ancylostoma caninum*), adult whipworm (*Trichuris vulpis*), and adult tapeworm (*Taenia pisiformis*, *Echinococcus multilocularis*, *Echinococcus granulosus* and *Dipylidium caninum*) infections in dogs and puppies two pounds of body weight or greater and six weeks of age and older.

### What dogs should not use INTERCEPTOR PLUS?

- Puppies less than 6 weeks of age or less than 2 pounds of body weight.

The safety of INTERCEPTOR PLUS has not been evaluated in female dogs used for breeding or in lactating females. Ask your veterinarian about the use of INTERCEPTOR PLUS prior to use in these female dogs.

### How should I give INTERCEPTOR PLUS?

- Prior to use, dogs should be tested for existing heartworm infections and treated at the discretion of the veterinarian.
- For heartworm prevention, administer at monthly intervals beginning within 1 month of the dog's first seasonal exposure to mosquitoes and continuing until at least 6 months after exposure to mosquitoes.
- INTERCEPTOR PLUS may be administered year-round without interruption.

**What is the most important information I should know about INTERCEPTOR PLUS?**

**Not for use in humans. Keep this and all medications out of reach of children.**

- Treatment with fewer than 6 monthly doses after the last exposure to mosquitoes may not provide complete heartworm prevention.

**What are the most common side effects that may occur while my dog is taking INTERCEPTOR PLUS?**

- Vomiting
- Diarrhea
- Depression/Tiredness

Other reported side effects include uncoordinated body movements, loss of appetite, convulsions, weakness and salivation.

### What is CREDELIO?

- CREDELIO is a monthly chewable tablet for dogs for the treatment and prevention of flea infestations and the treatment and control of tick infestations (lone star tick, American dog tick, black-legged tick, and brown dog tick)
- CREDELIO is only for use in dogs and puppies 8 weeks of age and older and weighing 4.4 pounds or greater

### What is the most important information I should know about CREDELIO?
